WHAT

- OEA awards Promising Practice Grants to enhance student learning opportunities for OEA members across Oregon. The grant is available for councils who would like to provide professional development opportunities to their members and to any OEA member with an innovative idea for their classroom.
- Councils can apply for up to \$1,000 for professional development activities.
- OEA Members can apply for up to \$1,000 for classroom projects and innovation.
- OEA will award no more than \$1,000 between both Council and individual.

HOW

- Applications must be completed online this year.
- Applications must be complete before they are sent to councils for final decisions.
- Councils can decide to fully fund a few grants or to partially fund any number of grants up to the \$1,000 allotment.

WHEN

- **Sep. 15** — Grants are live on OEA's website
- **Nov. 3** — All grants must be completed through the online application. If the deadline is missed, we will not be able to process the application. This includes council level grants.
- **Nov. 12** — All applications from your Council area will be sent to council leadership for review.
 - **Between Nov. 10 and Jan. 16** — Councils will meet to decide on grant awards.
- **Jan. 16** — Final Grantee list sent for processing and councils will notify all applicants of the awards or if they did not get the award.
- **Jan. 16 - 19** — Grants are processed and distributed to members.
- **June 30** — Final grant summaries are due
 - A link will be sent for grant reporting to all members who have been awarded a grant.
- **The due date for reports is June 30, 2026.**

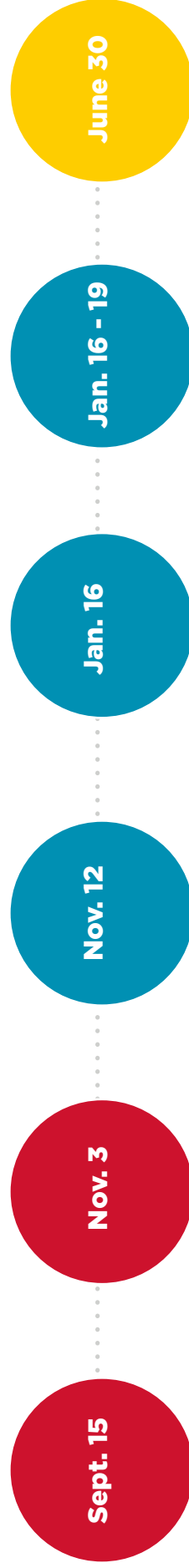

GRANT TIMELINE



*Council / grant committee
meets to make final decisions*

*Grant summary reminder
sent to grantees*

Application goes live!

Councils and OEA members must fill out an application to apply for grants.

Councils and individual members can apply for grants of up to \$1,000.

Applications are due!

All applications are due. **This is a firm deadline!** Applications will be reviewed for completeness.

Applications sent to Council

OEA will send all completed applications to the council to review. The council will choose who will be awarded and what amount they will award each grantee up to the \$1,000 allotment.

Final Grantees sent to OEA

Final grantees will be sent to OEA by Jan. 16. **This is a firm deadline!** Council will notify all applicants about grant awards.

****As of Jan. 16, any unused grant funds will be redistributed.**

Check Requests / Grant Funding

Check requests will be made from OEA and checks will be sent to members.

Grant Summaries Dues

Grant summaries are due to OEA using the form provided.
